Wedding Package

Venue Hire & Waterfall Ceremony Fee - \$1,200 gives exclusive use of the grounds and Restaurant. The Fee Includes Following:

- **\$600 deposit secures your day and is deducted from venue hire**
- **Minimum guests for exclusive use of venue 50.**
- **Music may be piped to Ceremony & Restaurant.**
- **Music and PA System Supplied, Registry Table & 2 Chairs at the Chapel and White Chairs for the guests**
- **White Linen Table Cloths and White Napkins**
- **Cutlery, Glass Ware & Crockery**
- **4 hour time frame of Sparkling wines, Wines, Beers, and soft drinks or juices (cost is extra). Options of either Standard Bev Pkge \$38p/p, Premium Bev Pkge \$44p/p or the Ultimate Deluxe Bev Pkge \$65p/p**
- **Champagne and other beverages for after the ceremony at the waterfall will be an extra \$10 per person for 1 hour**
- **1 hour allowed for the ceremony at the waterfall area.**
- **No BYO is allowed on site due to Responsible Service of Alcohol and the Liquor licensing Act**
- **Bar Service will cease in keeping with the Liquor Licensing Laws and noise regulations at the end of the 4 hours allowed (above).**
- **Music to finish half hour after bar closes.**
- **Venue to be vacated at the latest by 12 midnight.**
- **Table decorations etc can be organised with Ducks Crossing or other arrangements may be made.**
- **Hire and Draping of the bridal table and the cake table is approx \$200.00 extra**
- **Round tables can be arranged if desired.(cost is extra)**

- *Wedding cakes can be designed and supplied if requested by Ducks Crossing.*
- *Accommodation is available for the guests.(cost is extra)*
- ***Items not included are:*** *Room decorations, chairs covers, fresh flowers, themed settings, entertainment and public address system.*
- *The Manor is available to the bride and Groom. The Bridal Party may dress and leave from the Manor to the ceremony on the Dam in the grounds. **Viewing is available on request.** The package is \$330 and includes champagne and chocolates, breakfast for two the next morning and **exclusive use for the full day and night of the wedding.***
- ***Final Details – To be completed 14 days prior to event.***

 5. *50% of the contracted amount is due 30 days prior to the function. Then remainder of the contracted amount is due 14 days prior to the event.*

- **Cancellation:**
- *We hope this does not happen. However, in the event of a cancellation, a fee will be due as follows:*

- **The Deposit :**
- *Between 61 days and 119 days, inclusive of the arrival date:- 50% of the contracted amount*
- *Between 30 days and 60 days, inclusive of the arrival date:- 75% of the contracted amount*
- *Within 14 days of the arrival date:- 100% of the contracted amount*
